In accordance with the terms of the Company's Performance Share Plan ("PSP"), 5,665 ordinary shares of the Company with no par value were issued to certain individuals, none of which are either directors or PDMRs. Applications have been submitted to the London Stock Exchange and UKLA on the official list and shares are expected to be admitted to trading on the London Stock Exchange on 11 June 2019. Following admission, the total issued share capital of the Company will comprise 470,161,124 ordinary shares of no par value, each carrying one vote.
